What is the overall <b>deductible</b> ?	In-Network: \$500 member / \$1,000 family Out-of-Network: \$500 member / \$1,000 family	Generally, you must pay all of the costs from <b>providers</b> up to the <b>deductible</b> amount before this plan begins to pay. If you have other family members on the <b>plan</b> , each family member must meet their own individual <b>deductible</b> until the total amount of <b>deductible</b> expenses paid by all family members meets the overall family <b>deductible</b> .
Are there services covered before you meet your <b>deductible</b> ?	Yes. The following In-Network services: <b>preventive care</b> , <b>provider office visits</b> , mental health, <b>rehabilitation services</b> , and <b>habilitation services</b> are covered before you meet your <b>deductible</b> .
