What is the overall <u>deductible</u> ?	\$4,000 member/ \$12,000 family Benefits are administered on a calendar year basis.	Generally you must pay all the costs up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, they have to meet their own individual <u>deductible</u> until the overall family <u>deductible</u> amount has been met.
Are there services covered before you meet your <u>deductible</u> ?	Yes: Preventive care , provider office visits, services from Select LP Providers, outpatient mental health services, habilitation services , rehabilitation services , routine eye exams, are covered before you meet your deductible .	This plan covers some items and services even if you haven't yet met the deductible amount. But, a copayment or coinsurance may apply.
