What is the overall <u>deductible</u> ? Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> are covered before you meet your <u>deductible</u> .
