What is the overall deductible? Are there services covered before you meet your deductible?	Yes. Preventive care, Tiers 1, 2, and 3 prescription drugs, and the following Tier 1 Provider services: provider office visits, Rehabilitation services, and Habilitation services are covered before you meet your deductible.
