What is the overall <u>deductible</u> ?	Medical & <u>Prescription Drug Deductible</u> : Tier 1: \$3,500 member / \$7,000 family Tier 2: \$5,000 member / \$10,000 family Benefits are administered on a calendar year basis.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.
Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Preventive care</u> , Tiers 1, 2, and 3 prescription drugs, and the following Tier 1 <u>Provider</u> services: <u>provider</u> office visits, <u>Rehabilitation services</u> , and <u>Habilitation</u> <u>services</u> are covered before you meet your <u>deductible</u> .
