| What is the overall <u>deductible</u> ? | Medical & <u>Prescription Drug Deductible</u> : \$1,000 member / \$2,000 family Benefits are administered on a Plan Year basis. | Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay.
