What is the overall <u>deductible</u> ?	\$1,500 member / \$3,000 family Benefits are administered on a Plan Year basis.	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your <u>deductible</u> ?	Yes. Preventive care , provider office visits, prescription <u>drugs</u> , <u>emergency room care</u> , and <u>Rehabilitation</u> <u>services</u> and <u>Habilitation services</u> are covered before you meet your <u>deductible</u> .	This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply.
