What is the overall <u>deductible</u> ?	Medical & <u>Prescription Drug Deductible</u> : In-Network: \$3,400 member / \$6,800 family Out-of-Network: \$6,800 member / \$13,600 family Benefits are administered on a Plan Year basis.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
Are there services covered before you meet your <u>deductible</u> ?	Yes. Certain preventive drugs, and the following In-Network services: <u>preventive care</u> and routine eye exams are covered before you meet your <u>deductible</u> . What is not included in the <u>out-of-pocket limit</u> ?	Pediatric Dental Care, <u>premiums</u> , <u>balance-billing</u> charges, penalties for failure to obtain <u>preauthorization</u> for services, and health care this <u>plan</u> doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
Will you pay less if you use a <u>network provider</u> ?	Yes.
