Are there services covered before you meet your deductible?	Yes. Preventive care, Tiers 1, 2, and 3 prescription drugs, provider office visits, Non-hospital affiliated facility day surgery, Non-hospital based laboratory and imaging, and Rehabilitation services, and Habilitation services are covered before you meet your deductible.
