If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.
Are there services covered before you meet your deductible?	Yes. Preventive care, Tiers 1 and 2 prescription drugs, Primary care provider office visits, Non-hospital affiliated facility day surgery, Non-hospital based laboratory and imaging, and Rehabilitation services, and Habilitation services are covered before you meet your deductible.
