<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Preventive care, Tiers 1, 2, and 3 prescription drugs, and the following Tier 1 Provider services: Primary Care provider office visits, Rehabilitation services, and Habilitation services are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount.
